Item 2: Articulation/General Education: Manoj Wickremesinghe

	Common Course Numbering (CCN) changes need to done by October, to make AO's deadline of November 15, 2024.	
	Tyler Boogar asked if additional changes could be made to the CORs, when submitting courses for CCN. Manoj confirmed that it can be done. He advised not to remove from the COR, specifically Objectives and Content. Faculty can add to the COR, but subtraction from the COR can cause auditing issues.	
Articulation Update	Lori addressed the concerns faculty had regarding the subject changes to the courses needed for CCN. Communication Studies, our CMST will need to be changed to COMM. Political Science, our PSCI will need to be changed to POLS.	
	Manoj stated that during the transition period, we will have both subject codes for each. Communication Studies will have COMM for the CCN, and CMST for the other current courses. Political Science will have POLS for the CCN, and PSCI for the other current courses.	



ENGL A100 is going up 3 to 4 in Fall 2025. The state requires that the colleges do not make major changes to the CORs as it is currently approved. Colleges should only make following information:
-Subject -number title -Required portions of the template
Colleges are to hold on changes to units and hours. Once the CCN course is approved through, and a new control number is generated, then the college can submit the course for units and hours.
The English Department will need to submit ENGL A100 for CCN with the current 3.0 unit listing. Manoj will need to submit the revised ENGL for CCN through articulation. Once approved, he will need to resubmit again for the unit increase.
Jessica Gonzalez inquired about the guidelines for updating the affected programs of the CCN courses. Melissa Jauregui. informed the committee that the colleges will need to submit a memo to the state, listing the impacted programs from the CCN courses. Updates will need to be done to the course and program outlines that were impacted, removing the course that was replaced with the new CCN course. These changes will need to be done after the CCN course has been approved, and a new control number has been generated for the course.

Lori discussed unit alignments. She will contact the individual departments to discuss aligning units with actual hours listed and scheduled. Melissa J. confirmed that our District Office is requiring this. There are no exemptions to hours not matching units, other than following external accreditation guidelines.

Melissa J. suggested that the Committee adopt a policy requiring faculty to cite examples of other colleges that carry the higher unit value, and to attach the documentation to the unit change proposal.

The Committee will adopt a process for any course revision that has a unit increase. Any course proposal that has a unit increase will have to include justification that the course does not impacts ADTs, and justification of local colleges that have the same course and units.
