Curriculum Chair Update	Lori Pullman – Accreditation.	
	The college has begun campus-wide review of the ISER (Institutional Self- Evaluation Report). Standard 2 regarding Curriculum Development, has been done. The final report will be sent to ACCJC in August of 2025.	
	All were encouraged to review the standards and provide feedback where applicable.	
	OCC – Multiple Associate in Arts Degrees. The Committee's decision to have the college offering multiple Associate in Arts Degrees was brought forth by Lori to the Academic Senate.	
	CalGETC – The college will reduce units in the Social Sciences area. The amount of units was reduced from 9 units to 3 units. Students will still be able to choose the Social Sciences courses to fulfill other areas of the GE requirements.	
	The language for requirements for additional Associate in Arts degrees was discussed. The committee agreed to have the language mirror the language for the Associate in Science Degrees.	



	 "A candidate for an additional associate degree must complete the requirements for a separate major at Orange Coast College, including an additional 12 or more major-related units of credit at Orange Coast College beyond the requirements for the prior or additional degree."
